

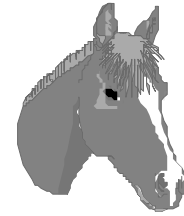

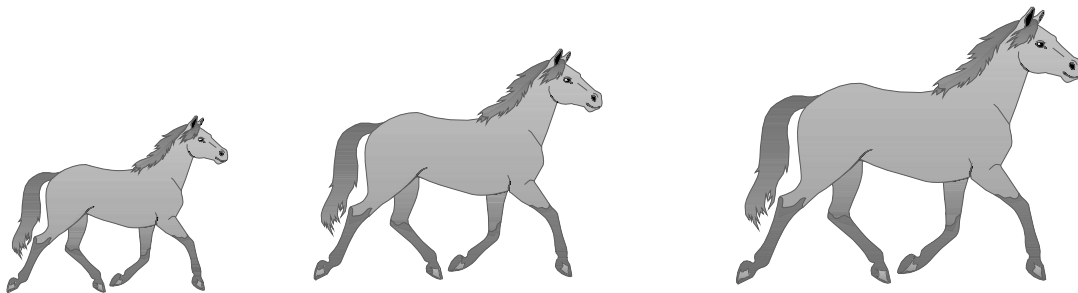

### **HEALTH REQUIREMENTS & PROCEDURES**

1. Read the section of the Fair Premium Book that pertains to 4-H horses.
2. Fill out front side of this form.
3. Attach a copy of recent Coggins Test and a copy of the rabies vaccination certificate.
4. Mail to 4-H Office before July 16, 2008. **No entries accepted at Fair!**
5. Bring horses to fair on August 11, 2008 - 4 p.m. deadline for arrival.
6. Upon arrival, bring original Coggins Test papers and rabies vaccination certificate to state veterinarian for verification, if requested by management.
7. Prepare your horse for the show and take home the ribbons!!
