2. BID PROCEDURE – The Auctioneer reserves the right to reopen bidding in the event of a tie bid and to reject a fractional advance if in his sole discretion such bid would negatively affect the sale.
3. RECORD OF SALE – The Auctioneer shall record all sales and his are deemed final.
4. REGISTRATION PAPERS – The seller shall be responsible for transfer of ownership to Buyer subject to a 15 day clearance for checks or guarantee of funds.
5. RISK OF LOSS – The Buyer assumes all risk of loss and responsibility immediately upon the sale and is not conditioned upon payment.
6. TERMS OF PAYMENT – All purchases must be cash or good check.

Dept. of Ag & Markets Law requires mandatory original proof of current negative Coggins test (w/in 12 months) on all horses and proof of negative TB test (w/in 5 years) for all Llamas and Alpacas. All out of state livestock must be accompanied by a current certificate of veterinary inspection (health chart).

A copy of the registration for each animal must accompany this entry form if selling animal as registered stock. Checks should be made payable to “Cornell Cooperative Extension”. Completed consignment forms may be sent to the 4-H office.
