- Exam Fee: \$100 exam fee, check only, Check made out to NYS DEC.

- License fee: All categories EXCEPT 3A and 3B: \$450 for a three-year certification  
Categories 3A and 3B: \$200 for a one-year certification
- You may bring a check for this fee to the exam, but it will not be processed unless you pass the exam.
