**Terms and Conditions**

1. All bidders are required to register prior to the beginning of the auction and are required to use the number issued them when identifying themselves as the successful bidder.
2. Every item is sold "as is". Neither Cornell Cooperative Extension of Putnam County nor the Auctioneer makes any warranties or representations of any kind or nature with respect to said property. All sales are final. Catalog descriptions are for simple identification purposes only, no representations are made as to authenticity, age, origin or value. Buyer relies solely on his/her own inspection and judgment when bidding.
3. Payment Methods – cash, personal check or Visa/MasterCard. Debit cards and 3<sup>rd</sup> party checks are not accepted.
4. All purchases shall be paid in full by close of auction, and preferably removed same day. Buyer must present proof of payment to remove item. Any items not removed by 5 PM, Sunday, July 26, shall be deemed abandoned by buyer.
5. The highest approved bidder is the buyer. In all cases of disputed bids, the property shall be resold, but, Auctioneer will use his judgment as to good faith of all claims and his decision is final.
6. Should a dispute arise after the auction, Auctioneer's records shall be conclusive in all respects.
7. Cornell Cooperative Extension of Putnam County reserves the right to withdraw any property prior to auction.
8. If the Auctioneer determines that any bid is not commensurate with the value of the article offered, he may reject the same and withdraw the item from the auction.
9. Ownership title passes upon the fall of the Auctioneer's gavel, and thereafter the property is at the risk of the buyer and neither Cornell Cooperative Extension of Putnam County nor the Auctioneer shall be responsible for loss or damage.
10. On all items so marked in the listing of auction items Title and transfer will be made directly from the donor of the item to the successful bidder and it is the sole responsibility of the donor and successful bidder to complete the transaction and transfer.
11. Purchasers are responsible for any and all damages incurred during removal of purchases.

Bidder does hereby herewith release from liability and waive any right of recovery from and all claims of any kind and nature whatsoever Cornell Cooperative Extension of Putnam County, its officers, directors, employees, agents and volunteers and Auctioneer from any and all damages, claims, or liabilities and/or injuries to persons or property of any type whatsoever, caused before, during, or after the auction.
